The overall goal of the project is conflict prevention and strengthening cross-border cooperation on climate impacts in Central Asia and Afghanistan. – German contribution to the new EU-CA Strategy of 2019

Intended results are:


- Improvement of the transboundary dialogue on climate, environment and security in Central Asia through scientifically based exchange of information at different levels and awareness-raising measures as well as public relations (joint action plan);
- Strengthened trust between the five Central Asian countries, Afghanistan and the international partner institutions.

Scientific support by the Potsdam Institute for Climate Impact Research (PIK), the Helmholtz Centre Potsdam - German Research Centre for Geosciences (GFZ), the Martin Luther University Halle-Wittenberg and the German-Kazakh University (DKU).



Water stress

Existing cooperation

- Agreement between the Governments of the Republic of Kazakhstan and the Kyrgyz Republic on the use of interstate water facilities on the Chu and Talas Rivers
- Agreement between the Government of the Republic of Uzbekistan and the Government of the Kyrgyz Republic on the interstate use of the Orto-Tokoy (Kasansay) Reservoir
- Agreement between the Ministry of Water Resources of the Republic Uzbekistan and the Ministry of Agriculture and Water Resources Turkmenistan on cooperation on water management issues
- Agreement between the Government of the Republic of Uzbekistan and the Government of the Republic of Tajikistan on cooperation to ensure the functioning of the Farhad Dam
- · Agreements on mutual supply of electricity
- International instruments: Energy Charter, UNFCC, Paris Agreement, UNECE Water Convention, etc.



Potential cooperation

- Uzbekistan can take part in the construction of the Rogun hydropower plant, which was discussed in a
 joint statement by the presidents of Uzbekistan and Tajikistan, Shavkat Mirziyoyev and Emomali
 Rakhmon, signed after the talks in Dushanbe in March 2018
- Uzbekistan and Kyrgyzstan signed an agreement on joint preparation of the investment project "Construction of Kambarata HPP-1.
- Potential NEXUS projects on transboundary water issues (energy, water, food security)
- Water allocation and energy exchange between CA countries, application of IWRM
- Joint investments
- Cooperation in production, removing trade barriers (Jan-Feb 2021: only 18,5% of Uzbekistan's trade was with CA), free flow of people and goods, etc.


